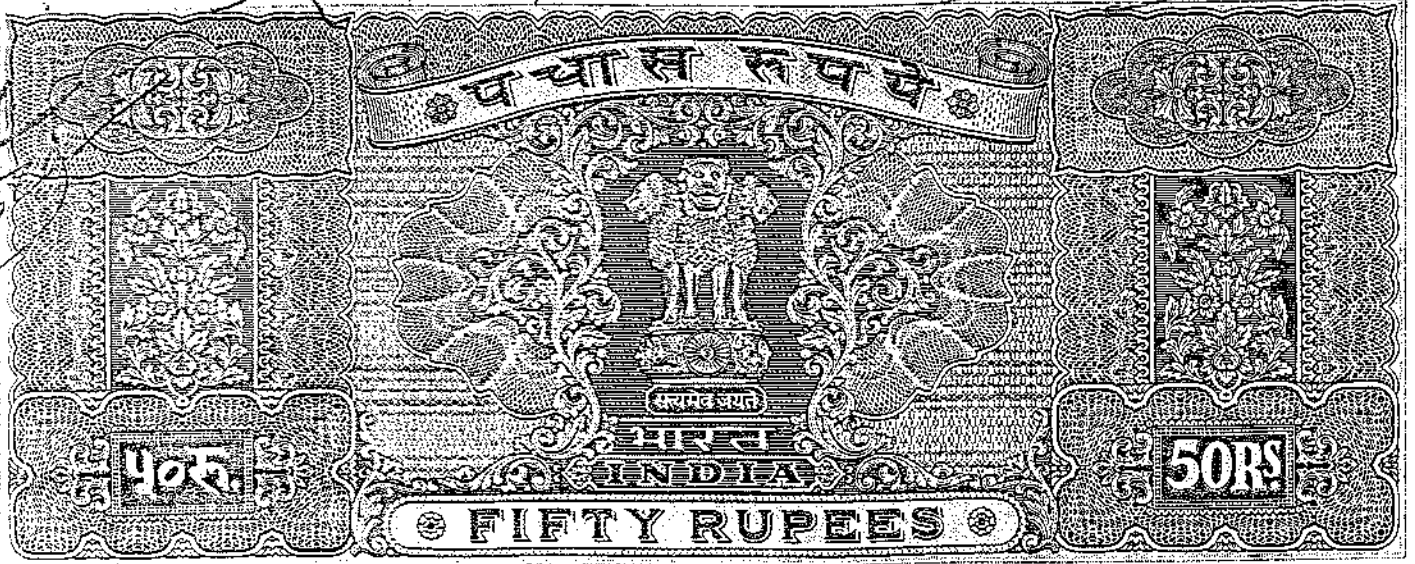

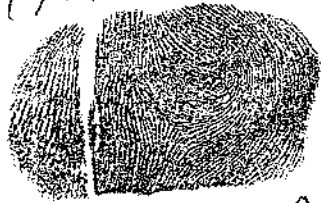

Whereas the founder is desirous to spread the importance of education amongst the public at large and to make necessary arrangement for educational development.

Whereas the founder has made up his mind to remove illiteracy from people of the Division and none of children may remain illiterate due to poverty.

Whereas the founder is desirous to encourage and enforce all types of education such as technical, medical and rural development.

Whereas Smt. Bimla Pandey w/o Shri Gyan Chand Pandey was also pious lady and she had also feelings like the founder she was also desirous to make some arrangement of development

 properties revocably for its maintenance and continuance
 which have been duly stated in a separate schedule appended
 herein below at the foot of this deed along with their
 approximate estimated value.

Now this indenture witnesseth as follows:-

- (1) The founder/settler is desirous of creating the
 trust in the name and style of " Bimla Pandey Memorial
 Gyan Niketan Trust " for pious/charitable purpose and

Deed of Trust

(1) The trustees here have also consented to set up a trust of without getting any reservation in the various rights and charitable obligation of the founder, may be fulfilled with better expediency, in proof of their willingness, they have made their signature/signatures after reading understanding and knowing the facts mentioned in the contents of this deed.

(3) The name and style of the trust will be "Bimla Pandey Memorial Gyan Niketan Trust which office is situated at S.P. Kothi Road, Daltonganj. This office may be removed or transferred at any other such place or places as the trustees may think fit and proper.

(4) In case of any vacancy amongst the trustees occasioned by death, resignation, voluntary retirement and incapability, the founder will fill up the vacancy and after his death the remaining trustees shall make the appointment according to the decision of the majority of the remaining trustees.

(5) In pursuance of the said wish and desire of the founder the founder do hereby grant, convey, transfer assign and assume to the trustees ALL THAT PROPERTY described in following Schedule AN DELIVERED the same hereto duly endorsed in favour of the Trustees to HAVE AND TO HOLD them all upon trust for the object and wish all subject to the powers, provisions and agreement hereunder declared and expressed.

(6) The trustee or trustees shall make necessary arrangement to obtain the land for establishment of school/schools and thereafter erect, build, construct on the acquired land.

The Trustees shall manage and control the said property and every part thereof as mentioned in the Schedule hereto and after paying paid Government revenue taxes and all expenses and management shall use the balance of income as well as the income from future securities which the same may hereafter be converted by them, for the recurring expenses of the school/schools any balance remaining after making such expense, shall be deposited in the nationalised Bank and invested in such manner as the trustees may consider proper.

(8) The Trustees shall have power to convert, increase and develop the income of trust so that wish and desire of the founder may be fulfilled but they shall have no power to sell mortgage otherwise transfer the property of the trust, without getting any permission from the founder of the deed or his legal heirs or without getting permission of the District Judge having jurisdiction over the subject.

(9) The founder in consultation with each other will frame Rules and Regulations for proper function of the trust which shall be registered before the proper authority provided under the law.
